OPEN LOAN OR CHECKING ACCOUNT = \$\$\$

*A new member is defined as anyone who has not had a membership account with FirstCCU for at least one year and is 18 years or older. Must meet membership eligibility requirements. Loans are subject to approval and must exceed \$10,000 (excludes unsecured loans). New checking account must complete 20 debit card transactions (excluding ATM withdrawals) within 60 days to qualify. Direct deposit required. Loan and checking account must remain active and in good standing for the first 60 days and at the time of payout. Referrer must be a current member of FirstCCU and in good standing to receive incentive. Referral must be submitted at the time of account opening in order to receive incentives. Referral incentives will be paid within 60 days following satisfaction of requirements as a deposit into the membership savings account. FirstCCU reserves the right to disqualify any referrals that we believe were not made in good faith. Program subject to change at any time without notice. Employees and their household are not eligible for this program. See MSR for more details.
